KEYNOTE SPEAKERS



Robert Gottliebsen AM has spent more than 40 years writing and commentating about business and investment in Australia. He has won the Walkley Award and Australian Journalist of the Year Award, two of journalism's highest honours. In 1974 he started the Chanticleer column in the Australian Financial Review, and later founded BRW Magazine, Personal Investor Magazine and Shares Magazine.

In 1999 he became host of the Business Daily TV show on Sky News. In 2000 he was appointed National Business Commentator at "The Australian" newspaper. Gottliebsen has played a unique role in Australian journalism, communicating business ideas and comments through "The Australian", TV shows, the internet and regular radio broadcasts. Robert continues to write in "The Australian".
